Presentations

Ms. Janet Afoakwah introduced Ms. Loni Cohen, Program Manager, Community Ecology Institute (CEI) for a presentation "Nourishing Gardens; Grow Food. Cultivate Community. Protect The Planet." Key takeaways from the presentation:

- The Nourishing Gardens program is a program of the Community Ecology Institute.
- Roots and Wings Based on the properties and is Home School Co-op group
- Green Seeds Internship High School students sign up and learn about Agroecology and Eco stewardship
- Agroecology Program Primary growing food program at the farm
- Nourishing Gardens Established in 2021
- Sustainable Skills Workshops

Two Properties:

Freetown Farm (6-acre educational farm where food is grown using regenerative agriculture practices)

Freetown Farm grows over 5000lbs of food. Support for the farm comes from dedicated volunteers.

The Green Farmacy Garden (focuses on plants that can be used for herbal medicine and research).

- 600 volunteers worked with CEI in 2023
- Food is donated to Columbia Community Care Food pantry and Laurel Advocacy and Referral Services (LARS) Food Pantry
- Other organizations have farms on the property:
 NAACP, HopeWorks, Grow it Eat it, Youth Garden, Climate
 Victory and UME Master Gardeners.
- Nourishing Gardens has training program Community members can sign up and learn how to grow their own food (5 weekly classes and a weekend session)
- Over 50 community gardens (many at schools that offer additional education and learning).
- CEI works with schools to determine the benefits of helping students learn to grow their own foods and provides outdoor classroom learning.
- 20 additional schools are interested in partnering with CEI.
- CEI offers Community Installation days where parents and the community can come out and assist with installing the garden in their community.
- Master gardeners help to sponsor gardens, Interfaith centers have been really involved in fundraising.
- CEI has applied for additional grant from the Chesapeake Bay Trust, which will help them to continue working with Swansfield Elem. School and offer additional trips to Harpers Choice.

Key notes:

- Nutrition-Getting fresh produce to student, families and Howard
 Co. communities without stigma
- Community Education-Nourishing Gardens Trainings help community members learn how to grow food in any space
- Community Gardens-Supports the development, installation and maintenance of food gardens in every community.
- Education-Community workshops that utilize garden spaces as a

| | Three mobile pantries were scheduled on 8/09, 8/16 and 8/23 at Deep Run Elementary, but because of tornado weather warnings/events, the 8/09 event was cancelled. The 8/16 event was held with less turnout due to miscommunication. 22 families (95 individuals) were served at 8/16 event. | |
| | The 8/23 event was scheduled on the same day as a Back-to- School event so in the interest of providing quality services, this event was rescheduled. Looking to have the make-up event on evening closer to the holiday. | |
| | Ms. Ross and Ms. Rambharat will have a meeting with the Supervisor of the Hispanic Liaison program to see how the organizations can work better together to reach more families effectively and how to have a little more control over the advertising to eliminate miscommunication. | |
| | Ms. Genesis Caplan held a demonstration during the 8/16 event that was well received. | |
| | Ms. Caplan mentioned that she was able to reach out to the Community Schools Coordinator and through that channel, she was able to connect with all the schools instead of each individual school principal, which wasn't as successful. | |
